

Terms & Conditions

For the submission of ebooks, and authored materials

Definitions

The “Site” Refers specifically to the <http://www.ebooksdiscovery.com> website, including all pages within the website and sub domains of the website and the legal owner of the <http://www.ebooksdiscovery.com> domain.

Ebook Any ebooks, stories or other written materials submitted in electronic form to the site for the purpose of either publication and / or sale on the site.

Submitter The individual or legal entity submitting an ebook to the site for the purpose of publication and / or sale of the ebook through the site.

1. Copyright for ebooks submitted to the site for publication and / or sale must be wholly vested in the submitter. Copyright information must be displayed in or on the ebook. Ebooks found to be submitted in violation of this requirement shall be removed from the catalogue.
 2. Submitters will provide a level of personal and contact information as required by the site, including an authorised email address for authorised communications and a bank account for payment of sales receipts. The site will NEVER require password access to a bank account.
 3. Ebooks must be provided free of significant defect with regard to spelling, grammar and punctuation and where possible submitted in an approved format (i.e. “pdf”, “lit” or “pda” format). The site will offer a conversion service from “Microsoft Word” or similar formats.
 4. The site reserves the right to undertake editing where the site determines this to be appropriate. Submitters will be advised of any editing undertaken to the ebook submitted by them and withdraw the ebook if the editing is deemed by them to be unsatisfactory.
 5. In the case of non-fiction, ebooks submitted to the site must be factually correct and the submitter wholly accepts responsibility for opinion expressed in the ebook.
 6. Ebooks submitted will not be libellous, racist, substantially derived from the published work of other authors or incite hatred of other individuals or groups.
 7. Ebooks with an explicit or strongly implied violent or sexual content will only be accepted for display in the appropriately designated “adult” section of the

catalogue.

8. The site will publish and / or display ebooks for sale entirely at its' discretion.
9. The site reserves the right to remove ebooks from the catalogue at any time for any reason, including business or reasons of appropriateness of content.
10. Submitters may for any reason withdraw an ebook submitted by them from display on the site. When so advised by an authorised submitter, the site will remove the ebook from the catalogue within 48 hours.
11. Submitters may determine the sale price of the ebooks submitted by them and vary this price at any time by advising the site in an approved manner.
12. Submitters may nominate a preferred category for the ebook submitted by them, or suggest a new category. The right to decide in which category an ebook is displayed is retained by the site.
13. The site reserves the right to determine the manner in which payment for ebooks is made to submitters. Payments will be made monthly once gross profits earned by a submitter (for one or more ebooks) reaches \$50.00 AUD.
14. The site retains the right to charge a one-off registration fee to display an ebook on the site.
15. The site retains the right to charge a fee for conversion of ebooks to an approved format where requested by the submitter.
16. The site will retain the lesser of 15% or \$2.00 (AUD) for each completed sale of an ebook. Notwithstanding, a minimum commission of \$0.75 (AUD) will be charged for each completed sale of an ebook.
17. The site reserves the right to vary all fees and commissions without notice.
18. Submitters may request advice on the sales of the ebook submitted by them at any time. The site will endeavour to provide this advice within a 7 day period.
